The Parrott Hall Coalition, consisting of the Preservation League of New York State, Landmark Society of Western New York, Friends of Parrott Hall, Ontario County Historical Society, and Geneva Historical Society, thanks you for allowing our engineer from Klepper Hahn and Hyatt access to Parrott Hall on Monday, June 4, 2018.

Having received the engineering report on June 14, 2018, we write to ask for additional time to work with OPRHP on how the Coalition might fund and implement the recommendations made in the report. The Coalition cannot present a fully-funded reuse plan without having worked out a clear path forward for site control with OPRHP.

We believe that the recommendations presented by Klepper Hahn and Hyatt are achievable, with an estimated stabilization cost of \$105,000, and stand ready to discuss the best path forward for stabilization and determination of the best reuse of the site.
